TERMS OF SERVICE

1. Site Content

1.1 This website is operated by Remedium Enterprise Ltd. Throughout the site, the terms "we", "us" and "our" refer to Remedium Enterprise Ltd. Remedium Enterprise Ltd offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

2. Use of Content

2.1 By visiting our site and/ or purchasing something from us, you engage in our "Service" and agree to be bound by the following terms "Terms of Service", including those additional terms of service and policies referenced herein and/or available by hyperlink. These Terms of Service apply to all users of the site, including without limitation users who are browsers, vendors, customers, merchants, and/ or contributors of content. Please read these Terms of Service carefully before accessing or using our website. By accessing or using any part of the site, you agree to be bound by these Terms of Service. You may not use our products for any illegal or unauthorized purpose nor may you, in the use of the Service, violate any laws in your jurisdiction (including but not limited to copyright laws). You must not transmit any worms or viruses or any code of a destructive nature. A breach or violation of any of the Terms will result in an immediate termination of your Services.
- 3.3 We reserve the right to refuse service to anyone for any reason at any time. You understand that your content (not including credit card information), may be transferred unencrypted and involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices. Credit card information is always encrypted during transfer over networks. 4. Placing an Order

- 4.1 You may place an order by filling in the order form on this website and by clicking the "Submit My Order" button. When you place your order, we will issue you with an order confirmation. We will do this by email.
- 4.2 When confirming contents of the basket, the customer will validate it definitively by payment. Order with payment obligation. The order will not be definitive until the payment of the corresponding total is paid. By placing an Order, you make an offer to us to purchase the Products you have selected. Your order implies acceptance of price and description of items available for sale and acceptance and compliance of our Terms of Service.
- 4.3 We reserve the right, but are not obligated, to limit the sales of our products or Services to any person, geographic region or jurisdiction. We may exercise this right on a case-by-case basis. We reserve the right to limit the quantities of any products or services that we offer.

5. Order Processing

- 5.1 You agree to provide current, complete and accurate purchase and account information for all purchases made at our store. You agree to promptly update your account and other information, including your email address and credit card numbers and expiration dates, so that we can complete your transactions and contact you as needed.
- 5.2 We will notify you that your order is being processed by sending you an Order Confirmation and invoice via email; however, we do not formally accept your offer until your order has passed our internal validation procedures for verifying the bona fides of each order placed, for the purpose of preventing credit card or payment fraud. Remedium Enterprise Ltd and its affiliates reserve the right to refuse service, terminate accounts, remove or edit content, or cancel orders in their sole discretion. We will confirm acceptance of your order and shipment of the goods you have ordered by email. If we cannot process or accept your Order after payment is received we will contact you by email or telephone.

Goods will be dispatched within 72 hours of purchase and often on the day of purchase.

6 **Delivery**

6.1 Delivery of Your Order

The estimated delivery times are in business days (Monday through Friday) excluding Public holidays. Although every effort is made to ship your Order according to the estimated delivery times provided, estimated ship times may change due to changes in supply or circumstances beyond our control. If your Product has not arrived after the estimated delivery time, please contact us here. Unless otherwise agreed by us, we will deliver your Products to the address indicated on your Order Confirmation. If no-one is available to take delivery of your Products, our carrier will leave a card so you can pick-up your Product from

your local Post Office. Where delivery is by our courier service and no-one is available to take delivery, they will leave a card requesting you to telephone them to arrange a suitable time and date for delivery. We will use our reasonable efforts to deliver your Products to you within the estimated delivery time indicated on your Order Confirmation; however, we do not guarantee that we will deliver within this time frame. Please Note: In some remote/regional areas our carriers can only deliver bulky items to the nearest transport depot. In these instances you will receive notification that your delivery is available for your collection from the transport depot.

- 6.2 If your product is received damaged or faulty, we must be notified within three (3) week days (Monday to Friday) of receipt of your product(s). It is important that you examine your product(s) immediately upon delivery. If any item is damaged or faulty contact us at info@remedium.store or through our website. We may require photographic evidence. We will require you to return the damaged item in its original packaging
- 6.3 Any fees/duties charged by customs are the sole responsibility of the customer. Failure to clear custom fees will result in a returns charge, which will be deduced from the refund amount.

7 Cancellation

- 7.1 You can cancel your order online at any point before completion of payment. After payment your order will be processed and dispatched. If the order has already been processed and/or dispatched you will need to return the order to Remedium Enterprise Ltd, in which case shipping costs will not be refunded. Please see our returns policy above. Your statutory rights are not affected.
- 7.2 We reserve the right to refuse any order you place with us. We may, in our sole discretion, limit or cancel quantities purchased per person, per household or per order. These restrictions may include orders placed by or under the same customer account, the same credit card, and/or orders that use the same billing and/or shipping address. To complete your return, we require a receipt or proof of purchase.

Once your return is received and inspected, we will send you an email to notify you that we have received your returned item. We will also notify you of the approval or rejection of your refund. If you are approved, then your refund will be processed, and a credit will automatically be applied to your credit card or original method of payment, within a certain amount of days, depending on your card issuer's policies.

8.4 Late or missing refunds (if applicable)

If you haven't received a refund yet, first check your bank account again. Then contact your credit card company, it may take some time before your refund is officially posted. Next contact your bank. There is often some processing time before a refund is posted.
